

FII OWNERSHIP OF NSE-LISTED COMPANIES PICKS UP: PRIME DATABASE

The percentage holding of FIIs in NSE listed companies picked up in the quarter ending 30th June 2016 at **20.09 per cent** (Rs. 20.13 lakh crore by value), according to Pranav Haldea, Managing Director, PRIME Database, on the back of net inflows of Rs. 14,671 crores in the June quarter.

Change in FII ownership

The **top 10 companies with highest FII holding** as on quarter ending June 2016 were Housing Development Finance Corp. (76.86 per cent), Bharat Financial Inclusion (63), Indiabulls Housing Finance (58.65), Tata Motors (DVR) (57.15), S.E.Power (56.95), KPIT Technologies (51.43), Shriram Transport Finance Co. (50.1), Housing Development & Infrastructure (48.21), Zee Entertainment Enterprises (48.12) and UPL (47.16).

The **top 10 companies with highest FII holding** in absolute value terms as on quarter ending June 2016 were Housing Development Finance Corp. (Rs.1.52 lakh crore), Infosys (1.09), HDFC Bank (0.96), Tata Consultancy Services (0.85), Reliance Industries (0.62), ITC (0.61), Axis Bank (0.56), ICICI Bank (0.55), Kotak Mahindra Bank (0.5) and Sun Pharmaceutical Industries (0.45).

On an overall basis, FII holding went up in 437 companies listed at NSE in the last 1 year with the average stock price return of these companies in the same period being a huge 37 per cent. On the other hand, FII holding went down in 577 companies listed at NSE. The average stock price return of these companies in the same period was 18.32 per cent.

Which FII owns what (only for cases where individual FII's holding in a company is greater than 1 per cent)

Disclosure of holdings by FIIs by name is only made for holdings in a company greater than 1 per cent. Considering only this dataset, the top FIIs which hold the largest positions in Indian stocks by value as on 30th June 2016 were as given in table below. It is important to note though that such cases (where an individual FIIs holding in a company is greater than 1 per cent) represent only 23 per cent of the overall FII holding (Rs. 4.57 lakh crore of the Rs. 20.13 lakh crore).

In terms of numbers, a total of 454 FIIs (ones holding greater than 1 per cent) are invested into Indian equities across all NSE-listed companies.

In terms of the geographical spread of FIIs (ones holding greater than 1 per cent), by value, U.S.A. leads (36.51 per cent) followed by Mauritius (21.21), Singapore (15.1), U.K. (7.24), Luxembourg (4.25), U.A.E. (4.14), Norway (3.32), Canada (2), Netherlands (1.01), Spain (0.86), Australia (0.83), China (0.57) and France (0.51).

By numbers, of the 454 FIIs, 33 per cent are registered in Mauritius followed by U.S.A. (25 per cent), U.K. (8), Luxembourg (6) and Singapore (5).

Note: The analysis is based on Shareholding Patterns filed by 1517 of the total 1532 companies listed at NSE for the quarter ending June 2016. As on 5th August 2016, 15 companies were still to file their shareholding patterns.
