# CONTRIBUTION TO PM'S RELIEF FUND SEES 418 PER CENT INCREASE, OVERALL CSR SPENDS UP BY 28 PER CENT: PRIME DATABASE

CSR spends by NSE listed companies saw a **huge increase of 28% in 2015-16**, according to Pranav Haldea, Managing Director of PRIME Database.

CSR law, which came into force in April 2014, mandates companies subject to the provisions of the Act to invest 2% of their net profit in CSR projects. Companies with net worth of Rs. 500 crore and above or revenue of Rs. 1000 crore and above or net profit of Rs. 5 crore and above have to spend 2% of average net profits of last 3 years.

According to PRIME Database, of the 1579 companies presently listed on NSE, 1520 companies were listed during FY 2015-16 (balance 59 have got listed subsequent to April 2016). Of these 1520 companies, annual reports for 2015-16 have been released by 1421 companies. Of these 1421 companies, 1332 had details relating to CSR given in the annual reports, while no such details were available for the balance 89. Finally, of the 1332 companies, 920 were applicable under the provisions of CSR in the Companies Act, up from 895 companies in 2014-15. **This analysis is based on these 920 companies.** 

According to PRIME Database, the average net profit of these 920 companies over last 3 years was Rs. 4.60 lakh crore (2014-15: Rs. 4.22 lakh crore). As per CSR requirements, amount required to be spent by such companies was Rs. 9,146 crore (2014-15: Rs. 8,372 crore). The companies, however, went one step further and decided to spend Rs. 9,309 crore instead (2014-15: 8,606 crore), Rs. 163 crore more than the requirement. However, Rs. 1,984 crore eventually remain unspent (2014-15: Rs. 2,583 crore) and the **final actual CSR expenditure by these companies was Rs. 8,345 crore** (2014-15: Rs. 6,526 crore), an increase of 28 per cent.

The Companies Act has prescribed 9 different schedules under which spends can be made. The schedule-wise spend was as follows:

Under Schedule VII (x), various areas such as supporting the differently abled & old age persons, expenses incurred on collective activities, contribution to private funds/ foundation, rural development, CSR department internal capacity building, animal welfare, creating awareness on human trafficking, community development for relief operation & donations, homes for orphans & measure for reducing inequalities faced by socially and economically backward groups etc. have been given by companies.

According to PRIME Database, Education received the maximum spends followed by Healthcare. A huge Rs. 1782 crore (or 21 per cent of the overall spend) was made under 'Other Matters'. Areas such as child mortality, improving maternal health, promotion of gender equality and social business projects saw negligible spends (It is important to note though that there could be overlap between the different schedules. For e.g., building toilets for women can be classified under healthcare as also under gender inequality).

In comparison to previous year, spends under Schedule VII (ix) viz. contribution to PMs funds saw the maximum increase (418 per cent) from Rs. 168 crore in 2014-15 to Rs. 701 crore in 2015-16. This was followed by spends on hunger/poverty (66 per cent increase) and gender equality (38 per cent). Spends on child mortality and maternal health saw the maximum decrease (22 per cent). According to Haldea, allocation as a per cent of total under different schedules though remained fairly constant over previous year.

According to Haldea, PSU spending saw a huge increase of 41 per cent from previous year. On an overall basis, 48 PSUs spent Rs. 2,078 crore in 2014-15. This went up to Rs. 2,936 crore by 47 PSUs in 2015-16.

The CSR Act also mandates companies to appoint a CSR committee comprising at least 3 members of the board of which at least 1 should be independent. 1197 out of 1520 companies had such a CSR committee in place. Several companies though went beyond the requirement. According to Haldea, as many as 331 companies had appointed more than 3 members.
